## REGISTRATION POLICIES AND PROCEDURES

### **School Year Class Procedure Acknowledgement**

Only healthy students should attend classes; free of fever, cough, shortness of breath or diarrhea within the last 72 hours (without fever reducing medicine) and 10 days after the onset of any such symptoms. If the student or anyone in their household has had an illness that involves fever, cough, shortness of breath or diarrhea, we require 10 days of exclusion from the onset of illness. Students without a medical condition or disability that prevents them from wearing a mouth and nose covering agree to wear a mouth and nose cover while in the building. Drop off and pick up for students can be facilitated by calling or texting 503-502-5728. No parents or guardians will be allowed into our facility during regular hours.

### **Course Offerings**

Class availability, day, time, duration or assigned instructors are subject to change at PMA's discretion. Registered students will be notified of any changes in their class as soon as possible. Students will be taken on a space available basis. Class size limits have been set to ensure a quality experience. Once the maximum limit has been reached a waiting list will be taken. Early registration is the best way to get into the classes you want.

### **Holidays/School Breaks**

Classes will not be held on:

New Year's Day, July 4th, Thanksgiving weekend, and Christmas. On all other holidays whether Federal, State or local, classes will be held. Any exceptions to this will be listed on the class calendar which is updated every twelve weeks.

A two-week Winter Break is taken the last week of December into early January. A one-week Spring Break is taken in March. A one-week Summer Break is taken in mid-June and a Fall Break the last week of August and the first week of September.

### **Term Length**

PMA separates classes into two terms: School-Year Session, and Summer Session. The School-Year Session generally runs from early-September to mid-June, and roughly mirrors the PPS school year. The Summer Session generally runs from mid-June to late-August. It includes a few of the same classes that are offered during the school year as well as all-day summer camps and workshops. To ensure that registration is well-organized, classes, camps, and workshops for each session are listed separately online.

Note: while classes have a set start and end date, **we do accept new enrollments year-round**. Mid-term enrollments are subject to instructor approval; however, this is rarely an issue. If you have any concerns about enrolling during the term, feel free to call or email our office.

Promotions from one level of a discipline to the next are made in August and become effective in September. Many of the disciplines that we teach here at PMA, particularly physical ones like dance, require the constant practice and improvement of a skill that can atrophy if left-off or neglected. Advancing from one level to the next generally requires a student to be willing and able to take class through the summer to ensure their continued growth.

### **Tuition Payment**

Auto-Pay Agreement in which Tuition is withdrawn automatically from a checking, savings or charge account on the 1st, 5th or 10th of each month. Contact our office if other arrangements need to be made. Payment will be drawn immediately at the time of registration to hold your space in class.

Tuition for classes is paid in advance and is not refundable. Any credit left on family accounts after 9 months will be considered a donation to PMA.

There is a \$35.00 returned check charge for any checks returned by the bank.

Termination of Lessons--One month's written notice is required to terminate enrollment in any class. Regardless of whether or not the student attends class for that month, the financial obligation remains for the required one month's notice. From the date of notice of termination, families will have 30 days to bring current any balances due on their accounts.

If for any reason these payment options present a problem or hardship to you and your family and you would like to work out a different solution, we are happy to work to meet your individual needs; just get in touch with us and let us know your situation.

### **Refunds/Make-up for Missed Class**

Tuition for classes is paid in advance and is not refundable. Missed classes can be made up in another comparable class within 60 days of the missed class. Please check with the office for information about which class options would be most appropriate. If you know in advance that you will be unable to attend two or more classes during the term, notify the office *at the time of registration* and credit will be given for missed classes. No tuition refunds or credits will be given after a class is missed.

### **Attendance/Lateness**

PMA reserves the right to have students who come late to class sit out for all or part of that class. Late arrival interferes, not only with that student's ability to learn, but all other students in the class as well. Repeated late arrival or absences may cause lack of promotion or exclusion from performance.

### **Termination of Enrollment**

*One month's written notice is required to terminate enrollment in any class.* Regardless of whether or not the student attends class for that month, they will be financially obligated to pay for the required one

month's notice. From the date of notice of termination, students will have 30 days to bring current any balances due on their accounts. Contact our Registrar to make arrangements.

### **Dance Class Dress Code**

Dancewear requirements differ depending on type and level of class. However, a few general rules do apply. No costumes, tutus, jeans, boxer shorts or other baggy clothing are permitted. They compromise the safety of the dancer and prevent the instructor from seeing the line of the body and giving adequate correction.

Failure to wear appropriate dancewear to class could result in students being asked to sit out the class. When class uniforms are not available, for girls, a solid color leotard with pink or black tights is suggested, and for boys, black leggings with a solid color t-shirt. In cold weather, a solid color dance sweater or fitted tee-shirt may be worn for comfort.

Long hair needs to be secured neatly in a bun or with a barrette. Short hair should be kept off the face with a headband or barrettes. Jewelry such as watches, bracelets, dangling earrings and rings should be left at home and not worn in class. Flying hair or jewelry can cause injury and interferes with class work.

### **Children's Class Observation**

If a parent is in the classroom on a weekly basis, the child has two authority figures in the room to relate to. As parents we cannot help but respond with smiles and approval when our child does something wonderful and register disapproval for inappropriate behavior. A parent's very presence divides a child's attention and creates a distracting situation not only for your child, but for others as well.

Class time should be a special moment for each child. Independence means that they have something very special that only they can share with you. The last week of each term is set aside for VISITORS DAY. We ask that you to observe your child's class at that time and not on a weekly basis.

### **Photo Release**

PMA Scholarships are based on financial need, and are awarded to students based on eligibility for the National School Lunch Program's free and reduced lunches. If your family is eligible for reduced lunch under the NSLP's guidelines, you may be awarded a 25% scholarship on one class. If your family is eligible for free lunch under the NSLP's guidelines you may be awarded a 50% scholarship on one class.
